CALL TO ORDER AND ROLL CALL

APPROVAL OF AGENDA**MOTION**

Commissioner Dailey made the motion to approve the agenda, seconded by Commissioner Knetsch.

- A. Police Chief – Chief Mahan reported he is feeling welcome after one week in. He is learning the department. They are moving forward with the retirement of Deputy Chief Wig and will be looking to fill that upcoming vacancy.
- B. Fire Chief – Chief Gilmore reported the new fire station groundbreaking will take place in April with a completion date planned for near the end of the year, late winter or early spring. Firefighter Evan Smith resigned from the city. With that vacancy and the upcoming expected retirement of Lt Hepker on August 21st, he will be requesting to open the testing process during the regularly scheduled June meeting.

Chief Mahan reported no issues with candidate Mike Hanson's psychological analysis and recommends moving forward with lateral hire.

- C. Determination of candidate Hanson's pass/fail status based on Medical and Drug Screening Examinations (Chapter 3, Section 6, Subsection H).

MOTION

Commissioner Richardson moved to pass candidate Mike Hanson based on pre-employment medical and drug screening seconded by Commissioner Dailey.

Chief Mahan reported no issues with candidate Mike Hanson's psychological analysis and recommends moving forward with lateral hire.

- D. Possible Conditional Offer of Employment for Police Officer Vacancy in accordance with City Manager's Letter.

MOTION

Commissioner Dailey moved to extend a conditional offer of employment to candidate Ryan Fisher for lateral police officer, seconded by Commissioner Richardson.

Chief Mahan reported that Ryan Fisher is a lateral candidate from Yorkville with a background and polygraph exam both with positive results. He recommends extending a conditional offer to move forward with psychological and medical testing.

Commissioners voted 3 Aye and 0 Nay; motion carried.


