# LETTER FROM THE CHIEF

February 15, 2025

Dear Mayor Braser and City Council Members,

On behalf of the dedicated men and women of the Sycamore Police Department, I am pleased to submit the 2024 Annual Report. This report includes an overview of activity, crime statistics, accomplishments, and continued efforts to provide service and public safety at the highest level. This summary will reflect the growth of the department and the efforts of your officers in the constantly evolving and challenging field of law enforcement and public service.

Our officers logged 24,209 total incidents, including 8,802 calls for service in 2024. As in years past, officers responded to a variety of incidents and requests, with a continued focus on both public service and public safety. Through City Council approval, the Police Department increased staffing in 2024 with the graduation of three new police officers in December of 2023. This increase, the first since 2009, supported the expanded services of the Police Department, as well as the growth of Sycamore in population, housing, and the business community.

Leveraging equipment and technology remained a priority as evidenced by increasing the number of grant-funded license plate readers, procuring upgraded grant-funded body worn cameras, and adding an unmanned aerial system (UAS) with enhanced capabilities. Beyond progressing with technology, the Police Department invested in our greatest asset, our personnel, with approximately 6,000 hours of training. Multiple and various training opportunities included advanced guidance in DUI detection, crisis intervention training, drills for responding to active threats, and progressive leadership courses.

I would like to commend our staff for providing outstanding service to our residents, visitors, and the business community throughout the year. Their dedication was recognized by personal letters, phone calls, emails, text messages, and many “thank you”s passed along to recognize their work. They are the face and backbone of your Police Department and enable the City of Sycamore to continue to be a safe place to live, work, visit, and attend school. As 2025 will bring transition with a new Chief of Police, I am confident the staff of the Sycamore Police Department will continue to build on their strong foundation of quality and professional policing for the City of Sycamore.

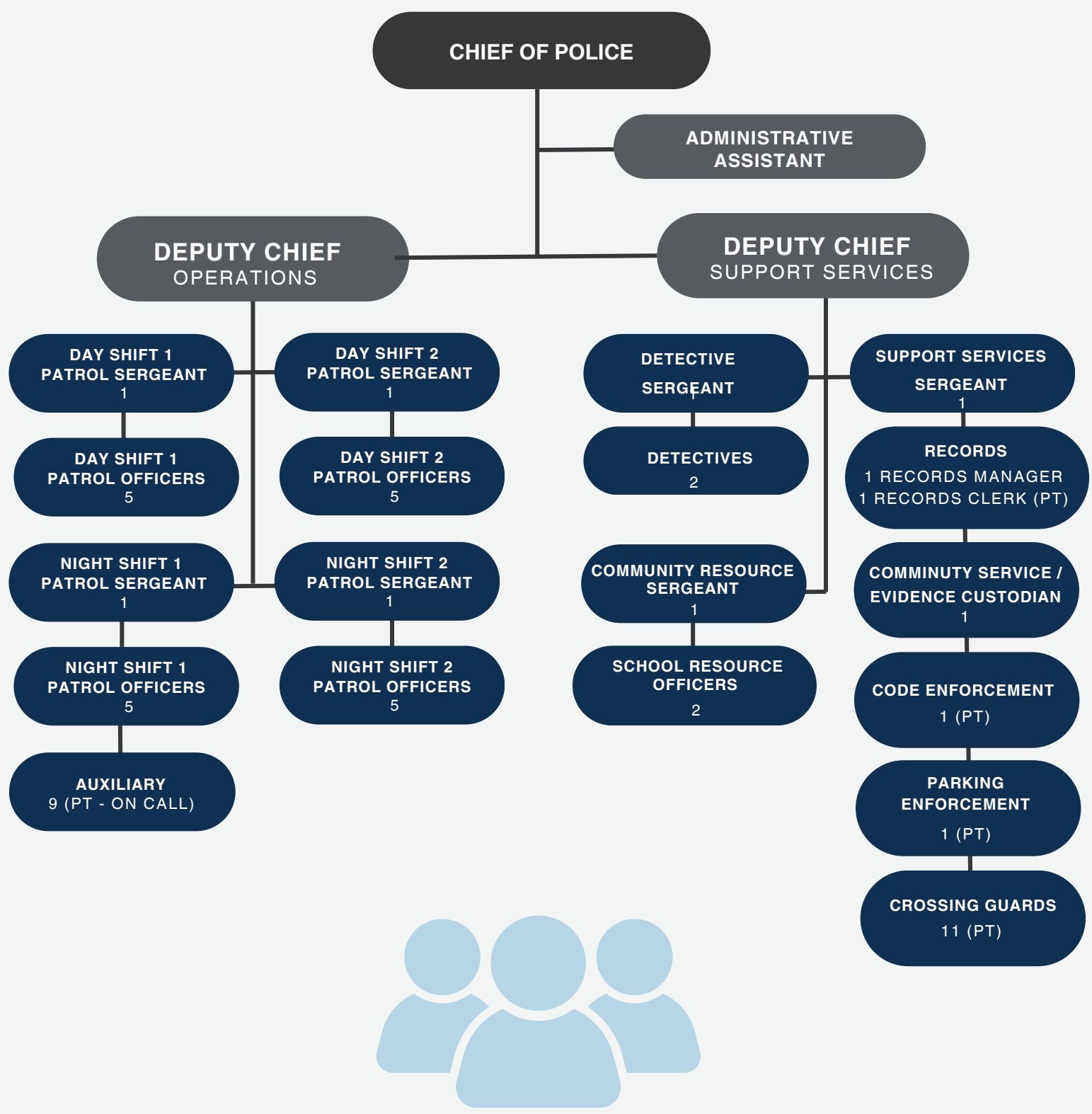
## VISION

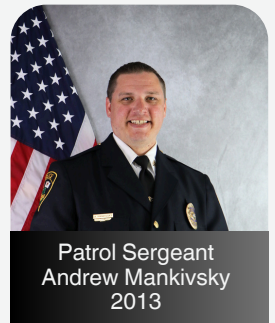

# LEADERSHIP



Chief Winters is tasked with overall leadership and accountability. He serves as chief policy maker and guides the direction of the department. He is the primary liaison with the community and city administration and represents the department at city council. The command staff is supported by Administrative Assistant Jennifer Poe-Diehl.



Deputy Chief Jeff Wig oversees the Operations Division which includes the Patrol Division, special events, social media, and community outreach.



Deputy Chief Joseph Meeks oversees the Investigations, Community Resources, and Support Services Divisions. This includes the School Resource Officers, records management, building / fleet maintenance, quartermaster, and technology.



# OPERATIONS DIVISION

The Operations Division, commonly referred to as the Patrol Division, operates 24 hours a day, 365 days a year and functions as the true backbone of the department. Each of the 12 hour day and night shifts are comprised of a Patrol Sergeant and 4-5 Patrol Officers.

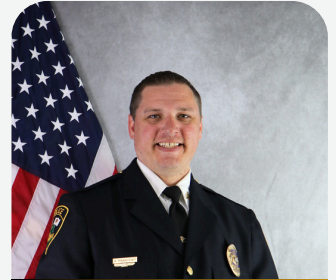

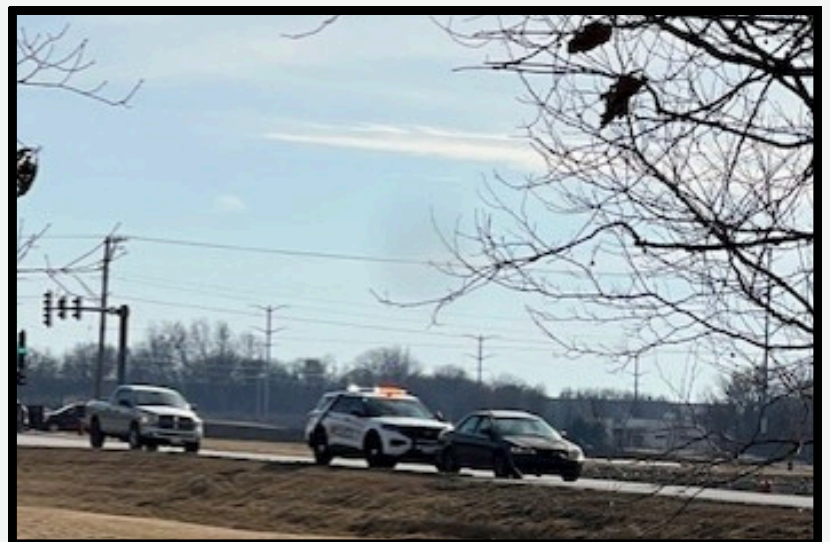

The Patrol Division is responsible for maintaining public safety, enforcing laws, and responding to various calls for service during their assigned hours. Specific duties include:

- Responding to both emergency and non-emergency calls.
- Conducting both city-wide patrols and those designed to target a specific need or incident, such as speed related complaints and home/business checks for example.
- Traffic enforcement and traffic crash response.
- Investigating incidents, making arrests, and report writing.
- Community engagement by interacting with residents and businesses to build relationships and foster community trust.
- Assisting other area agencies as needed.



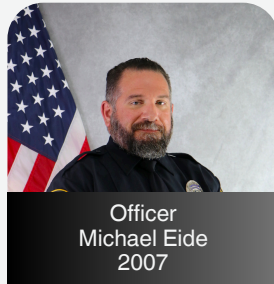




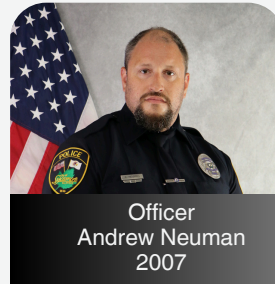

# INVESTIGATIONS

The Investigations Division is led by the Detective Sergeant and includes two general case detectives. The division is responsible for handling more complex and/or long-term investigations, while also acting as a supporting resource for the Patrol Division. Additional responsibilities include Sex Offender Registration and Verification Checks, Alcohol and Tobacco Compliance, DeKalb County Major Crimes Task Force, Internet Crimes Against Children, Background Checks, and FOID / CCL / Clear and Present Danger Compliance. The division is overseen by the Deputy Chief of Investigations and Support Services.

## 2024 NOTABLE CASES

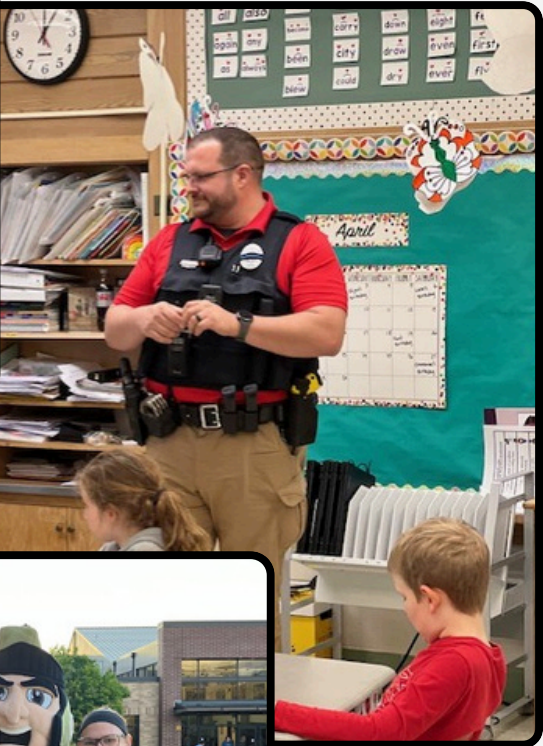
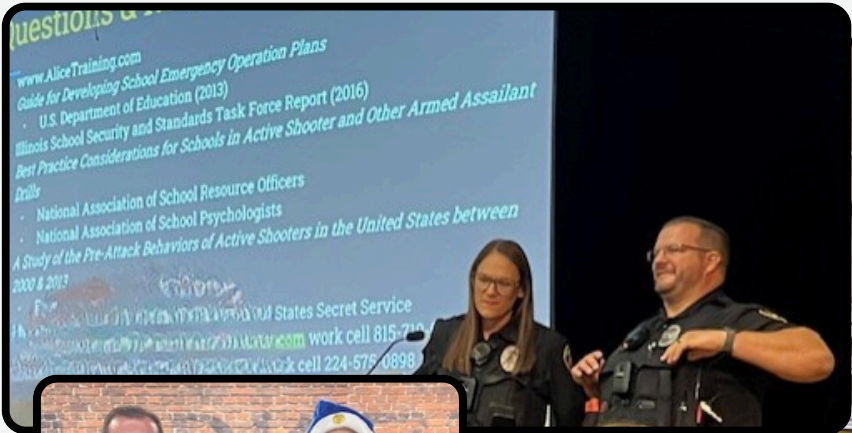
- **Aggravated Battery:** In February 2024, a female juvenile reported inappropriate contact by a staff member at Sycamore High School. The investigation identified seven victims, and the offender was charged with six counts of aggravated battery.
- **Forgery/Fraud:** In March 2024, a local business reported check fraud involving an altered check deposited into an unauthorized account. The investigation identified an offender from outside the community, who was charged with forgery.
- **Kidnapping:** In June 2023, two out-of-state bounty hunters unlawfully entered a Sycamore residence, tased, handcuffed, and kidnapped a man, transporting him to Indiana without notifying local authorities. They were later charged with kidnapping, unlawful restraint, and weapons offenses in 2024.
- **Aggravated Home Repair Fraud:** In September 2024, two elderly residents were defrauded of over \$20,000 by a fraudulent construction company. The offender, an Irish national, was identified and charged with aggravated home repair fraud. The City of Sycamore arranged for the driveway to be repaired at no additional cost to the victims.



# COMMUNITY RESOURCES

The Community Resources Division is supervised by the Community Resources Sergeant and includes two (2) School Resource Officers (SRO). One SRO is assigned to the Sycamore High School and the second to the Sycamore Middle School; while together they share the responsibility of responding to the needs of the district elementary schools. The division is further supported by our Therapy K9, Dooley.

While working to promote safety in our schools, the Community Resources Division is also responsible for presenting at various public meetings and trainings, our social media presence, and assisting with special events.





# SUPPORT SERVICES

The Support Services Division is supervised by the Support Services Sergeant and is staffed by a full-time Records Manager and Community Service Officer/Evidence Custodian. Additionally the division is comprised of several part-time members to include a Records Clerk, Code Enforcement Officer, and Parking Enforcement Officer.

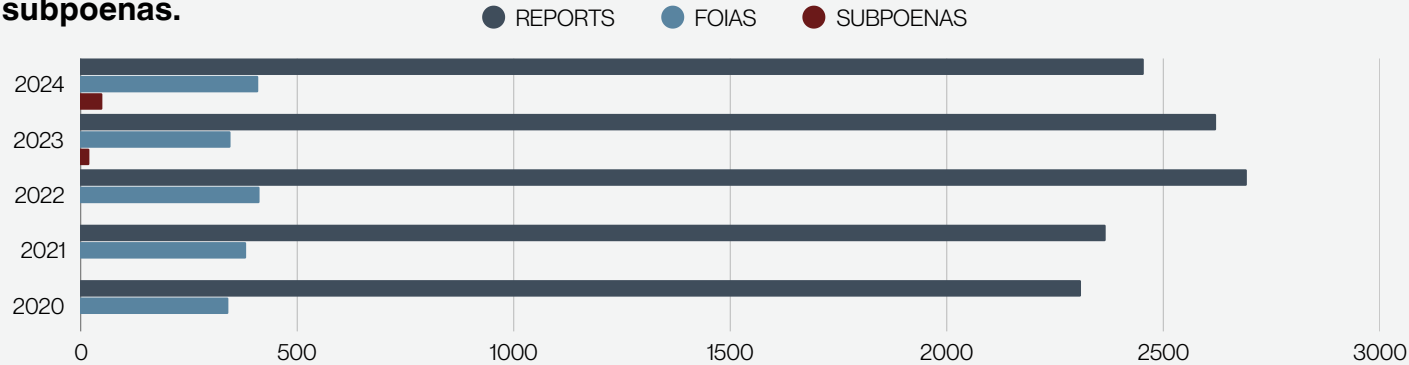
Our front office staff serve as the face of our agency for everyone who comes into the police department seeking assistance.

Support Services encompasses the following areas of responsibility:

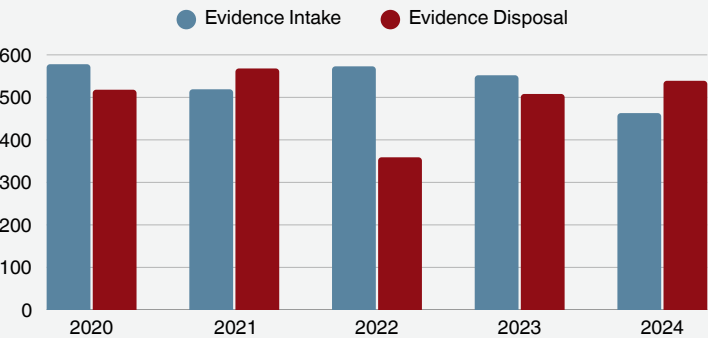

- Downtown parking enforcement and meter maintenance



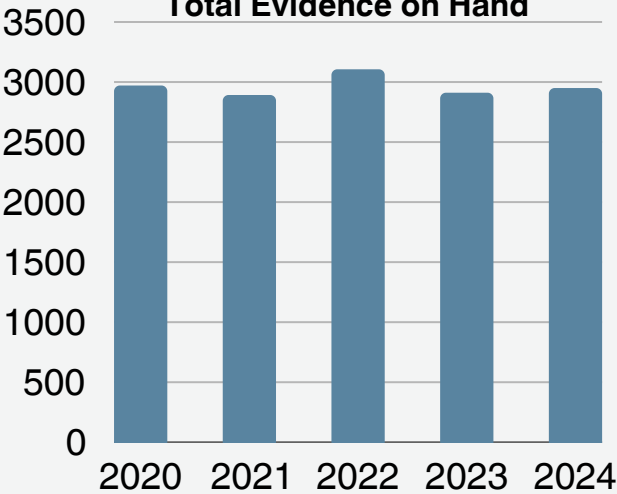
In 2024, the records division filed 2,455 reports, and answered 410 FOIA requests and 50 subpoenas.

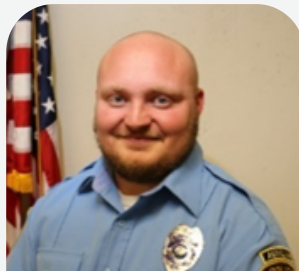

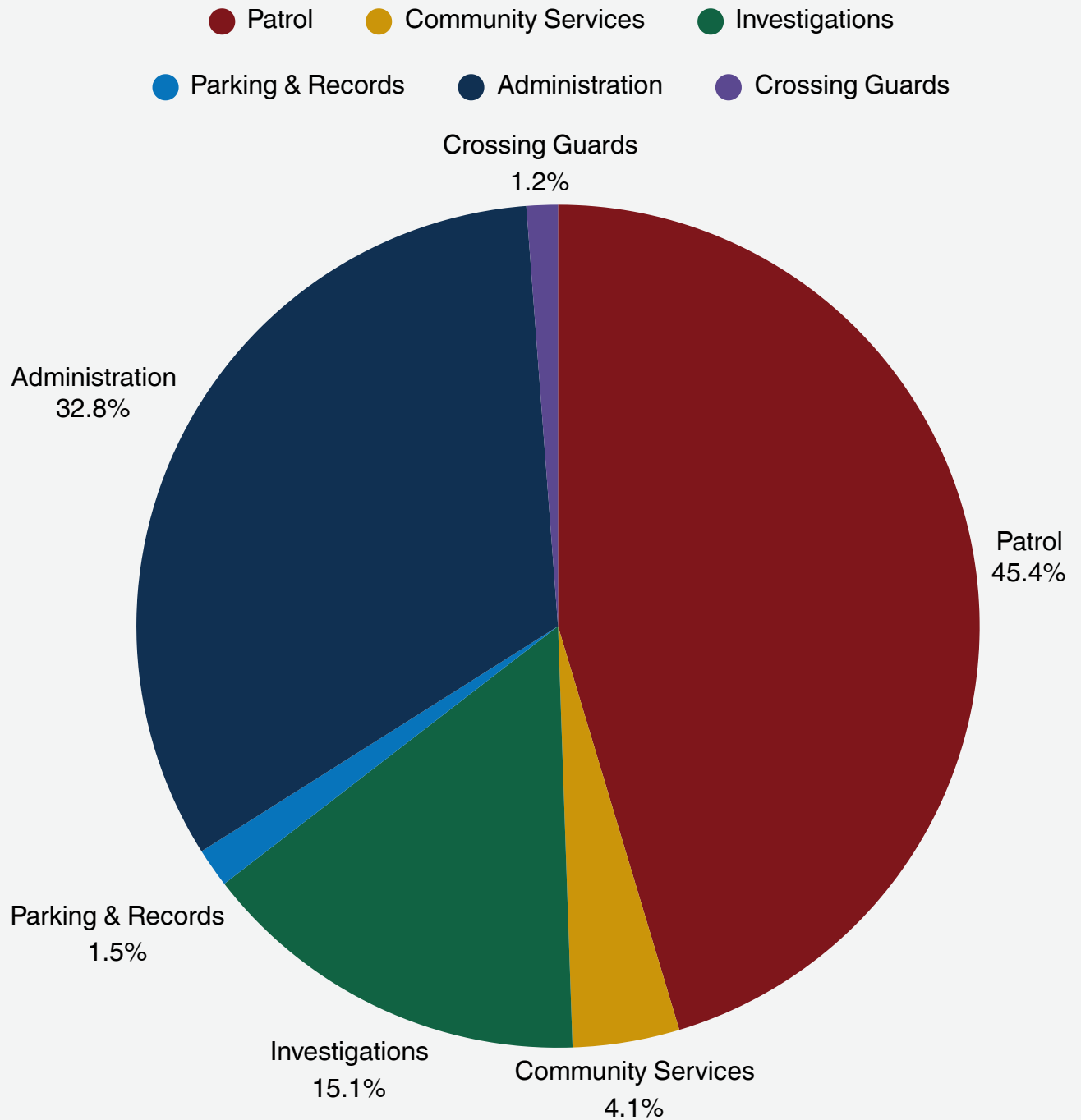

# NEW IN 2024

This year, we upgraded a number of equipment pieces officers utilize daily and for special circumstances. We have a new Live Scan Thales CS500f machine for all of our fingerprinting purposes. Each officer was issued a new V700 Body Worn Camera. Two new AEDs were put into service for our patrol officers to carry on every shift. We are deploying a new patrol shield as well. Our Drone fleet has expanded, and we picked up a metal detector too.

Two new trainings were introduced in 2024. FBI LEEDA and STOP THE BLEED Training. FBI Law Enforcement Executive Development Training is designed to advance the science and art of law enforcement leadership. Two of our officers are STOP THE BLEED Instructors and put on a training for all of our officers. The goal is to stop or slow the bleed during an emergency and increase survival rates.

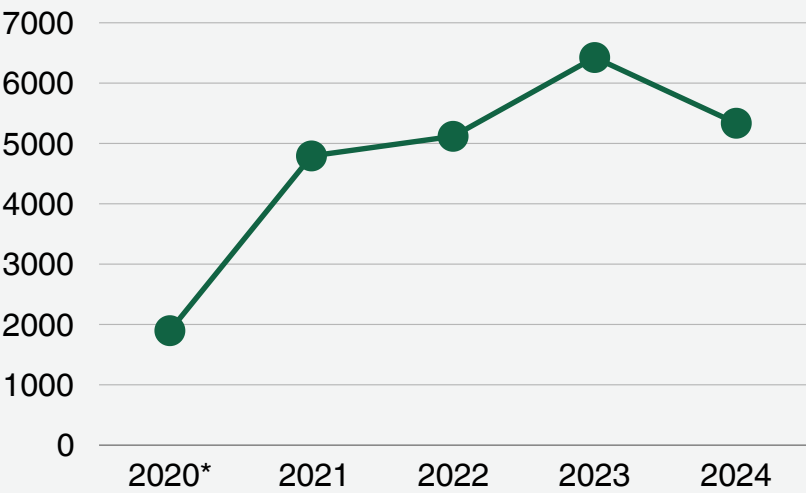

# TRAINING



Training Hours Yearly Comparison



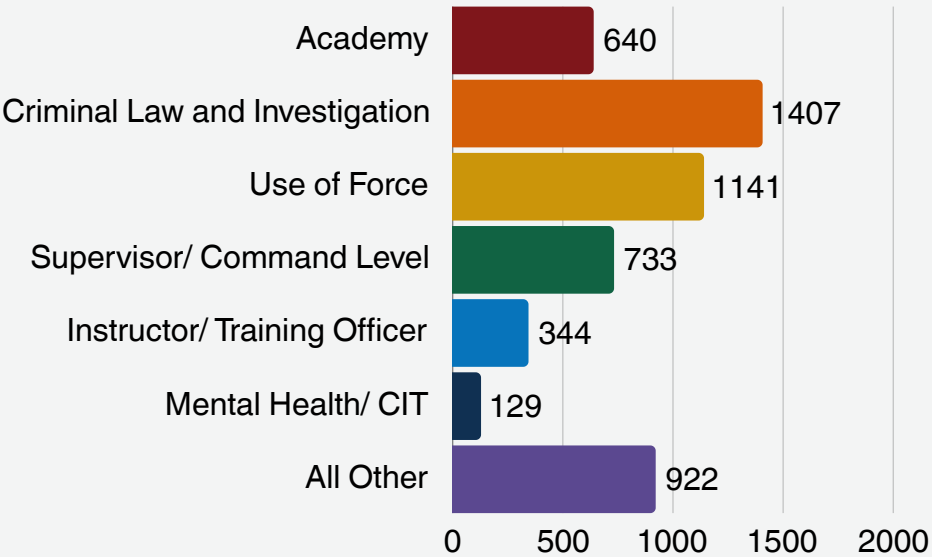
The Sycamore Police Department places a high value on providing officers with as much training as scheduling and budgeting allows.

This year, we have a heavy focus on criminal law and investigations, as well as use of force. Annually, Sycamore officers participate in a multi-agency Rapid Deployment Training.

As our laws are altered, we respond by providing corresponding training. Sycamore Police Department utilizes in-service training, computer-based and simulation training, the state mobile training units and training from outside sources.



In 2024, officers attended a total of 5,335 hours of formal training. This does not include an officer in the field training program upon completion of the Academy, nor our new lateral officer. Also, many officers proactively do training to work through scenarios they encounter on a daily basis.

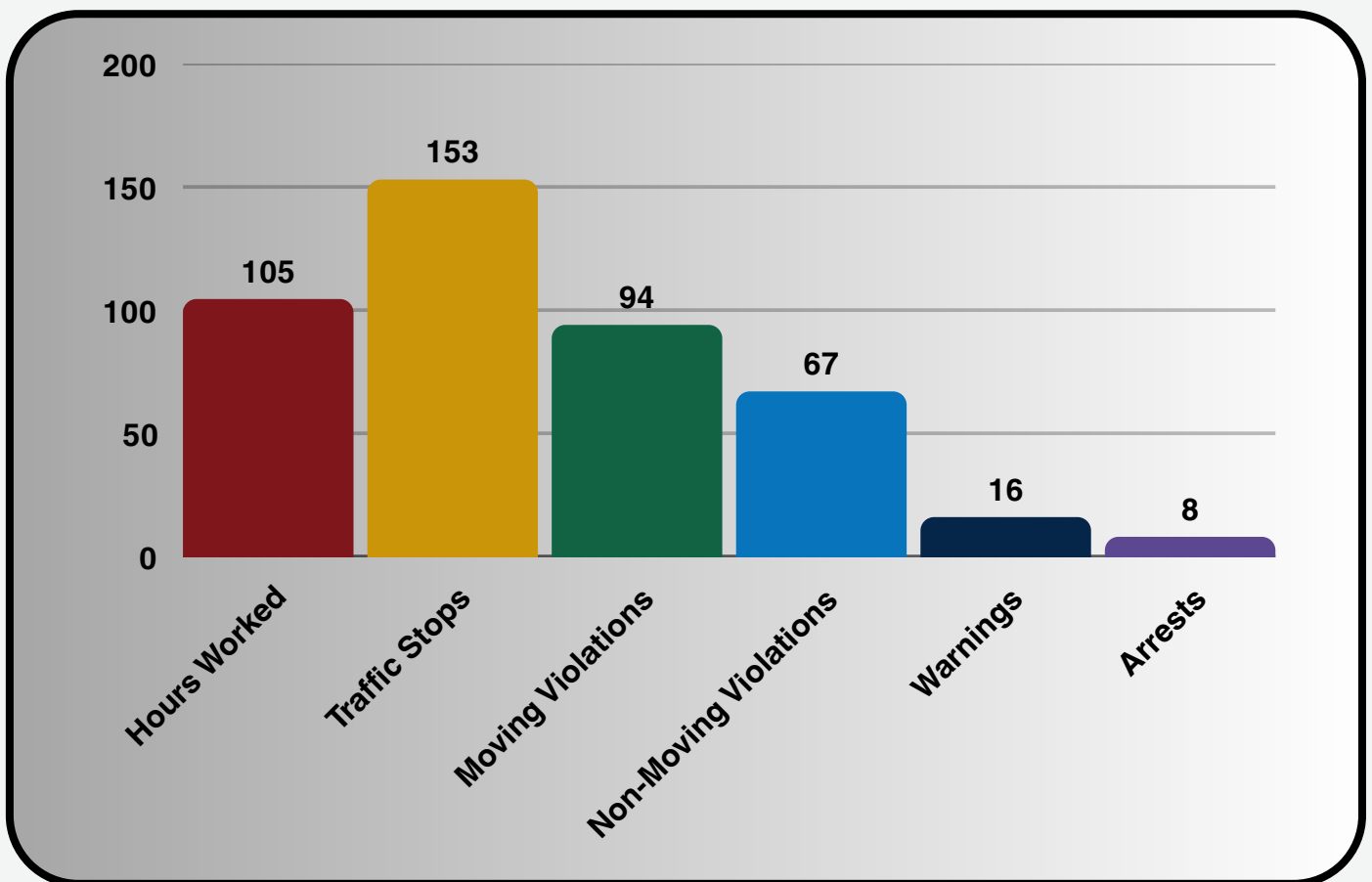


# IDOT STEP Grant

## *Sustained Traffic Enforcement Program*

In 2024, Sgt. John Keacher managed the IDOT STEP Grant Program by working with Illinois Department of Transportation representatives to ensure grant funding was utilized in a timely and appropriate fashion. The Sustained Traffic Enforcement (STEP) Program allows officers to focus on high visibility enforcement at specific times and on specific dates throughout the year. The police department was awarded \$6,267.04 to reimburse the city for personnel costs.

Focused enforcement was conducted during the following campaigns: Thanksgiving, St. Patrick's Day, Memorial Day, Independence Day, Labor Day, Speed Awareness, and Distracted Driving. These campaigns are focused on increasing safety for motorists and work toward reducing roadway fatalities to zero. Officers worked a total of 104.5 hours during 2024. 153 traffic stops were conducted and 165 enforcement actions were taking. This led to 94 moving violation citations, 67 non-moving violation citations, and 8 arrests.

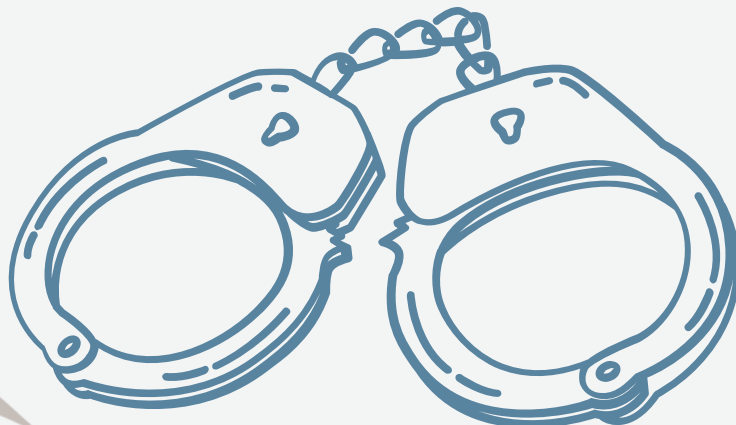

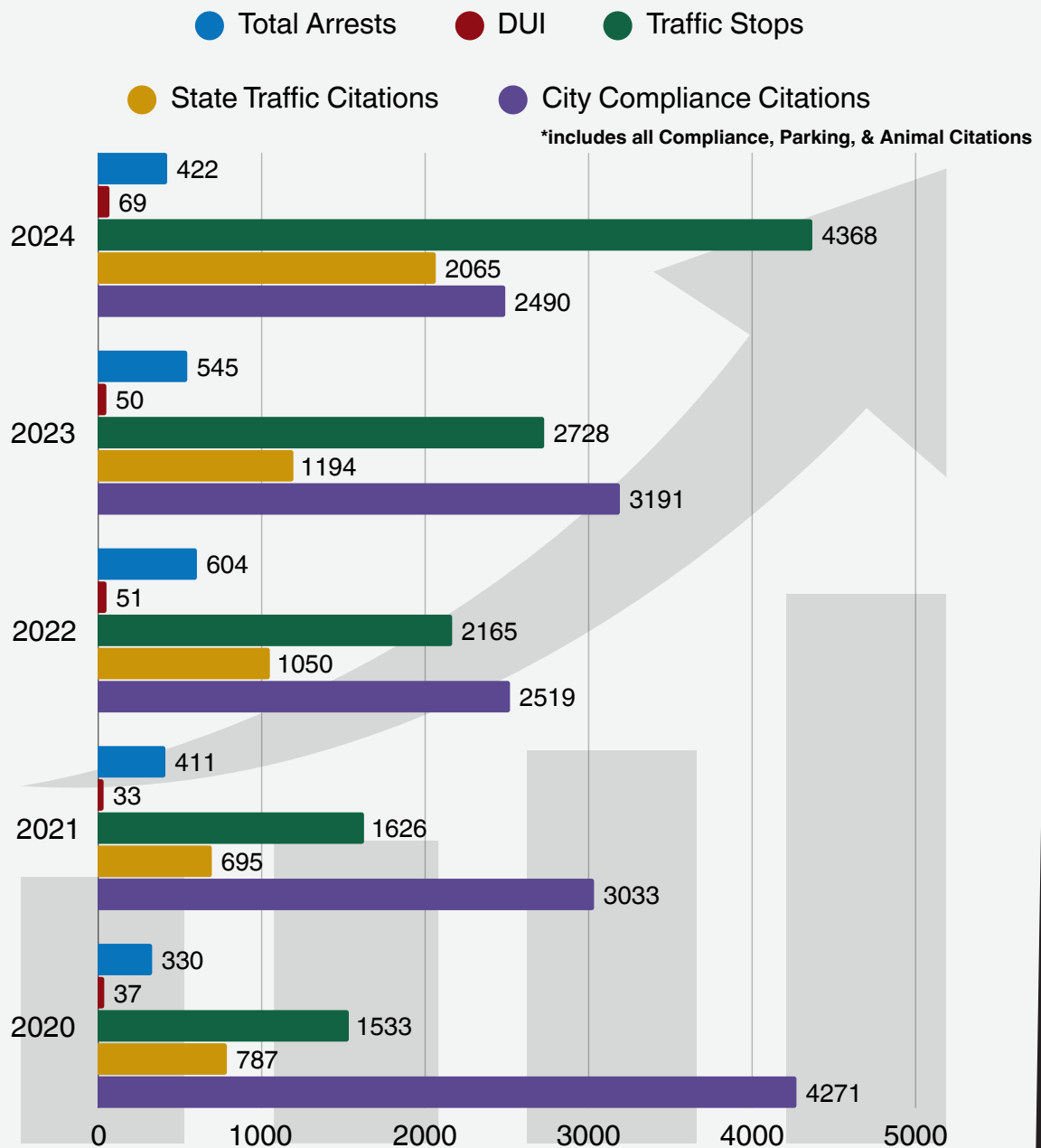

# CRASH DATA

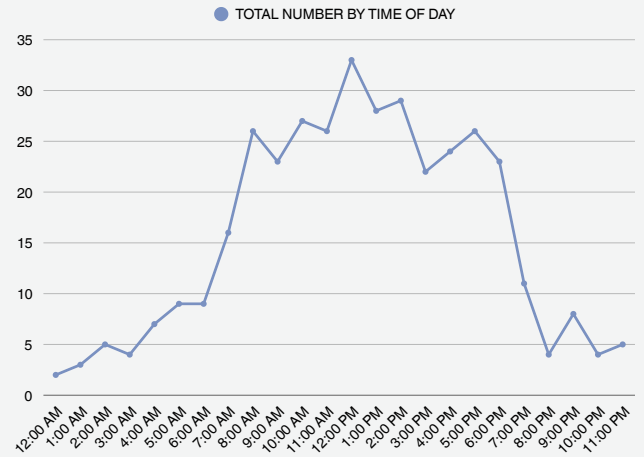
In 2024, officers responded to a total of 374 traffic crashes.

The peak times for traffic crashes were found to be during daytime hours between 12:00 PM and 2:00 PM.

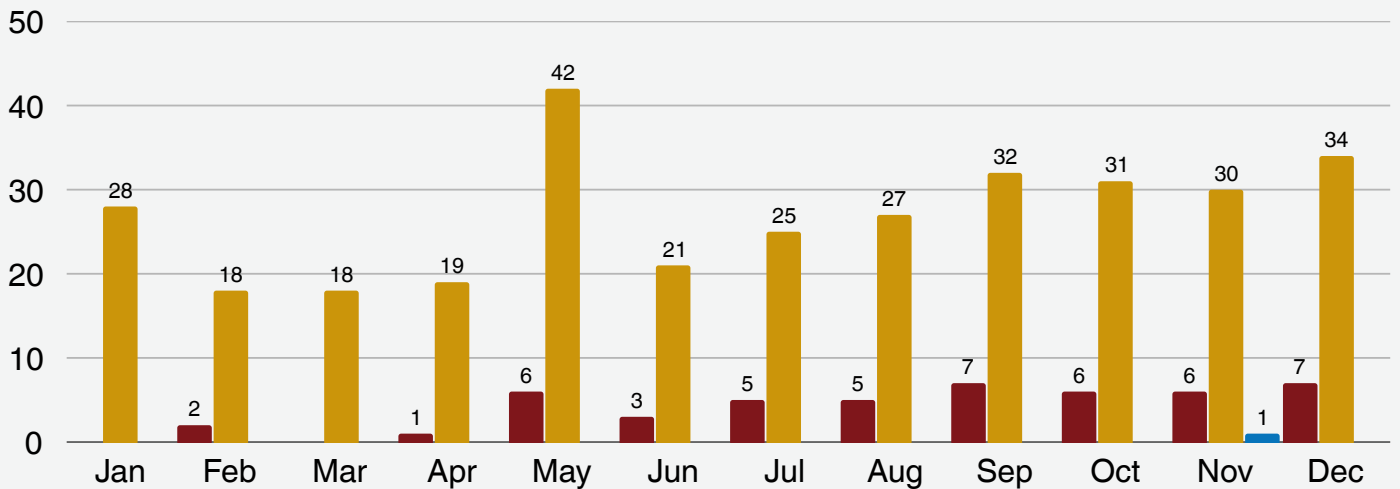
Top 5 Contributing Factors:

- Driving knowledge and experience



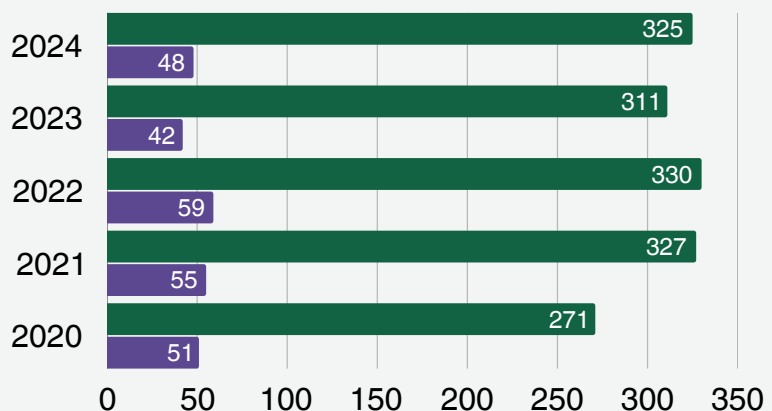
## Total number of Traffic Crashes by Month

# COMMUNITY ENGAGEMENT

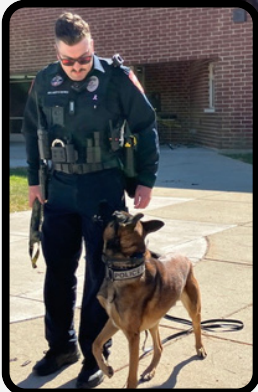

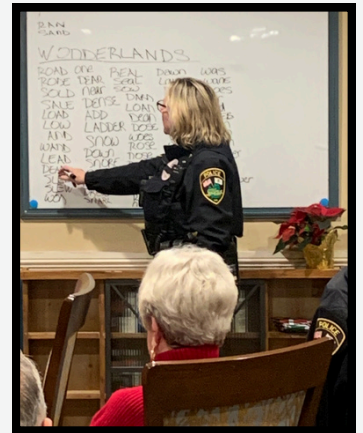


# SPECIAL EVENTS

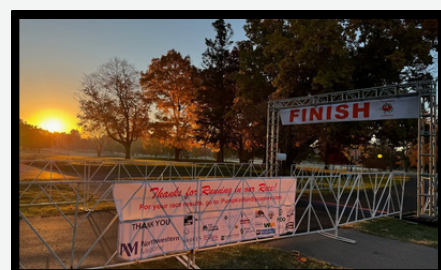


YMCA Senior Expo was staffed by Elder Care Service Officer Burrell. She was on hand to answer questions and meet with many seniors.

# ACCREDITATION

March 29, 2024 the Sycamore Police Department was awarded reaccreditation by the Illinois Law Enforcement Accreditation Program ILEAP. The Sycamore Police Department first earned accreditation in 2014. Accreditation is the ongoing process whereby agencies evaluate policy and procedure against established criteria, and have compliance with those criteria verified by an independent and authoritative body, the Illinois Law Enforcement Accreditation Council. The criteria, or standards, are policy development guidelines that represent a level of quality service delivery. The true indicator of compliance, however, lies with the evaluation by trained, independent professional peers. The establishment of meaningful and professional standards and an evaluation for compliance to those standards are, therefore, the two fundamentals of an accreditation program.

# FLEET MANAGMENT

The 2024 fleet consisted of 23 vehicles throughout the year to include:

- 9 marked patrol vehicles
- 1 marked patrol K9 vehicle
- 2 marked school resource officer vehicles
- 7 unmarked administrative vehicles
- 2 support services vehicles
- 2 special use vehicles - UTV and Golf Cart

The patrol fleet ranged in age from 2000 to 2025 with the most vehicles being 2023 models. The remaining fleet ranged in age from 2019 to 2021, with a majority of those vehicles being pre-2021 models.

Throughout 2024, there were 2 new patrol vehicles added to the fleet. 2 older vehicles were removed from the fleet and either sold or turned over to other city departments.
